
On July 24, 2000 (כ"א תמוז, תש"ס) Sandy Milgraum and Sima Milgraum appeared in front of the undersigned panel of the Beth Din of America, the forum chosen to hear this matter by the Va'ad Harabonim of Raritan Valley, the rabbinical board of the Orthodox community where both parties live. Sandy Milgraum, although he physically appeared in front of the Beth Din of America declined to accept the jurisdiction of the Beth Din of America, and stated that he would not comply with the directives of the Beth Din of America.


Until such time as Sandy Milgraum submits to the jurisdiction of the Beth Din of America or some other *bet din* that the parties mutually agree upon, the Beth Din of America feels that it is proper and appropriate that members of the community under the auspices of the Raritan Valley *Va'ad Harabonim* to distance themselves from Sandy Milgraum. Specifically, we feel that it is appropriate that:

- * Every Jewish person in the Raritan Valley area not speak to Sandy Milgraum other than when absolutely necessary.
- * Every Jewish person in the Raritan Valley area decline to host Sandy Milgraum in their homes or to feed him or give him drink, or invite him to their parties or otherwise socialize with him.
- * Every *gabbai*, synagogue official or other communal member in the Raritan Valley area decline to seat Sandy Milgraum in the synagogue, or call him to the Torah or grant him any honor.

All Raritan Valley Jews are to distance themselves from Sandy Milgraum as much as possible until such time as he submits to the jurisdiction of the Beth Din of America or some other *bet din* mutually agreed upon by the parties.
